Who We Are:

Project partners Annapolis Valley First Nation, Glooscap First Nation and the Municipality of the County of Kings want to build a community solar garden on a closed landfill in Meadowview. All partners agree that the solar garden can only succeed if the design, development and operating processes are environmentally and socially responsible.

What Is Proposed:

Based on community interest and studies evaluating the best use for the site, project partners are proposing a seven megawatt (MW) solar garden. It is estimated a system of this size would produce enough clean, renewable energy to provide electricity for an estimated 800 subscribers (households) per year.

Our Shared Purpose

To reduce harm to the environment in the local communities we serve, and elsewhere in the province, by decreasing greenhouse gas emissions and increasing access to sources of clean energy. The goal of the Meadowview Community Solar Garden is to transform a closed landfill site with limited repurposing options into a hub of renewable energy harnessed from the sun.

Generate enough electricity for about 800 households to subscribe, at no cost, to the clean, renewable energy produced by the solar garden and receive a \$0.02/kWh savings from Nova Scotia Power.



Create local jobs and opportunities for contractors during the development, construction, operation and decommission phases.



Produce emission-free electricity, reduce greenhouse gas emissions and help the Province reach renewable energy targets.



Provide returns to project owners Annapolis Valley First Nation, Glooscap First Nation and the Municipality of the County of Kings.



Provide an annual financial return to the community of Meadowview.
