



November 2024 Fast Facts from Council Chambers

“Fast Facts from Council Chambers” is a quick summary of some key takeaways from Council meetings held in November 2024. For more background information, use the links below the list of motions to find agenda packages and meeting recordings.

Motions from the Nov. 5 Council meeting:

- Appoint Coun. Riley Peckford to the office of Deputy Mayor for a one-year term. (More details are available in this [news release](#).)
- Give Second Reading to and approve a change to the text of the Land Use By-law to permit “existing uses” within the Comprehensive Neighbourhood Development (R5) Zone as described in [Appendix A of the Sept. 10 Planning Advisory Committee agenda](#).
- Approve the discharge of a Development Agreement registered on Aug. 26, 2008, involving lands located at 1386 Lockhart Mountain Road.
- Authorize the Mayor to appoint three Councillors to the Nominating Committee for a one-year term.
- Enter into Winter Maintenance Services Agreements with the following companies for the listed zones between Nov. 15, 2024, and April 30, 2025: Rick Balsor Welding to be awarded zones 1-5, 8 10, 13 and IJ Corkum’s Excavating Limited to be awarded zones 6-7, 9, 11-12 and 14.
- Approve the following three engineering consultants for future/fixed plant infrastructure design and engineering services from Nov. 5, 2024, to March 31, 2026: CBCL Limited, Dillon Consulting Limited and Stantec Consulting Limited.
- Approve the following three engineering consultants for future linear infrastructure design and engineering services from Nov. 5, 2024, to March 31, 2026: DesignPoint Engineering and Surveying Ltd., Englobe Corp. and exp Services Inc. & exp Architects Inc.
