Reporting to a Recreation Coordinator, the Recreation Intern will work collaboratively to plan the framework and support the delivery of youth day camps and mini camps (in various locations) as well as a variety of engaging community play activities for all age groups throughout Kings County during the summer months. The responsibilities of the Intern will also include overseeing and supporting the Play Specialist Lead and Paddle Program Lead, to achieve program goals and ensure the safety of participants, interacting with parents/guardians, and collaborating with the Municipality's Community Development staff.

The Summer Recreation Intern will specifically plan, organize, and collaboratively deliver a variety of unique events and programs in the Kings County area.

The Recreation Intern will help to organize and participate as a leader in the Kings County area summer staff Training Session, Valley Summer Recreation Staff Training Day, and other broad support, as needed, to Recreation Services.

We are seeking an enthusiastic, organized, and self-motivated individual for this role. The ideal candidate will be in the 3rd or final year of a recognized University or Community College Recreation Management Program, possessing both administration and programming experience. However, applicants with similar training and experience will also be considered. Previous involvement in or supervision of summer camps is an asset. Access to an automobile throughout the summer is necessary.
